## **Grant of Stock Options under the Employee Stock Option Scheme of the Bank (ESO Scheme)**

- 2. Vesting Period: 3 years from date of grant, spread at 33%, 33% and 34% at intervals of one year from the date of grant.
- 3. Exercise Period: 5 years from date of vesting.
